



2026 Washington County Fair Animal Exhibitor Camping Rules and Regulations

ONLINE REGISTRATION FOR CAMPING ONLY

REGISTRATION DEADLINE – Wednesday, July 22, 2026

1. Only animal exhibitors and their families are eligible to camp at the Washington County Fairgrounds beginning Monday, July 27, to Sunday evening, August 2, 2026.
 - The online Registration Form is located on the fair website (washingtoncountyfair.org) under the Fair Guide tab.
 - **NEW:** A \$50 fee per camping unit will be charged for camping during the fair. The fee can be paid in advance by credit card using the invoice that will be sent to you.
 - **NEW:** The camping fee increases to \$75 on Saturday, July 25, 2026.
 - **NEW:** Starting at 9 AM Monday, July 27, 2026, you may only pay your pre-registered camping fee and for general admission tickets at the Information Office in Building B.
 - Daily general admission tickets for each day of the fair must be purchased for each person in the camping unit.
 - Pre-paid camping hang tags and general admission tickets can be picked up in Information Office in Building B starting at 9 AM Monday, July 27, 2026.
 - The number of camping permits is limited due to space availability.
2. Each camping site must have at least one (1) adult, 21 years of age or older, who will be responsible for all people and equipment in the camping space. An adult is required to stay overnight in the camping unit during each night of camping.
3. Camping is only allowed Monday, July 27, 2026, to Sunday evening, August 2, 2026. **Camping is NOT allowed on the fairgrounds prior to Monday, July 27.**
4. All camping units should be at a minimum of 10 feet from the next unit.
5. Camping sites are to be kept clean of trash. Trash must be disposed of in designated trash containers.
6. Skateboards, hoverboards, motorcycles, bicycles, rollerblades, roller or inline skates, motorized scooters (except handicap scooters) or ATVs are NOT permitted on the fairgrounds.
7. Open fires are not permitted.
8. No electricity or water hook-up is available.
9. **A dump station is not available. Dumping fluids on the ground is strictly prohibited.**

10. Generator use is permitted between 7 AM to midnight.
11. No dogs or other pets are allowed on the fairgrounds, except for bonafide service animals.
12. Individuals camping may not use the showers on the fairgrounds during the fair.
13. For security reasons, all people staying in the camping unit must be listed on the registration form.
14. The fairgrounds does have a Severe Weather Policy in place. However, there are limited safe shelters (bathrooms) on the fairgrounds. Campers are responsible for seeking their own shelter during severe weather.
15. Use or possession of narcotics or other illegal drugs is prohibited on the fairgrounds.
16. The Washington County Fair/Washington County Agricultural Society assumes no responsibility for damage or injuries to campers or their property.
17. Fair staff and/or Law Enforcement have the authority to close and evacuate any camping area as they deem necessary.
- 18. Displaying a camping hang tag is required. Compliance will be checked and enforced.**
